 **Mandatory Climate Reporting Preparation (AASB S2)**

 **City Beach**

Cress is supporting **City Beach to advance its climate reporting maturity** by helping test and strengthen governance, systems, data, and decision making processes needed for future mandatory reporting. The team is completing an AASB S2 gap analysis, climate-related risk and opportunity assessment, scenario analysis, quarterly carbon measurement, and metrics and target setting, in order to help prepare for mandatory disclosures.
